QUALITY POLICY

The main goal of ARMANDO VICARIO srl is the full satisfaction of the Client's needs and expectations, and to achieve and maintain a high QUALITY STANDARD OF THE PRODUCTS WE SUPPLY. The foundations that allow the company to successfully pursue its goals regarding quality are: complete improvement of the Quality Management System and its constant adjustment to the evolution of the Company and regulatory framework. In particular we place the client at the center of attention, trying to understand its expectations and needs. The company policy is therefore aimed at:

- Satisfying the clients' needs, even if not directly expressed.
- Ensuring that the items we produce are compliant with the applicable regulations and specifics, and that they respect the fitness for use, performance, safety and reliability requirements.
- Conducting business respecting the environment and the people's health and safety.
- Developing the company culture towards the concept of "total quality".
- Respecting each and every rule or standard applicable to the products.
- Keeping aspects related to risks, opportunities, relations with stakeholders and analysis of the context we are in continuously updated.

These objectives and the actions needed to reach them (with responsibilities and timelines) have been decided by General Management and Quality Assurance during the review meeting of the Quality Management System. Furthermore, they have been communicated to all company managers through the disclosure of the General Management review. It is hereby renewed the responsibility of the Quality Manager, directly employed by General Management, in order to ensure the continuity of the Quality System management.

ENVIRONMENTAL POLICY

The General Management of ARMANDO VICARIO srl proceeds to the definition of its "Environmental Policy" in the framework of a broader vision of the company strategy and its positioning in the market. The company strategy is inspired by the following guidelines:

- Maintain conformity to and respect of the legal provisions, current environmental regulations and other internal requirements
- Pursue constant improvement towards prevention, reduction of the environmental impact and pollution tied to our own activities.
- Identify and evaluate the environmental effects and risks due to accidents, potential unanticipated events and emergency situations.

- Maintain the Environmental Management System efficient by enforcing all the UNI EN ISO 14001 requirements, and what is described in the Environmental Management Manual.

- Continuous adjustment to the increasing social and legislative needs in regards to environmental protection. Following them where possible through an adequate planning of activities and initiatives.
- Periodical review of the objectives by General Management, aiming at the improvement of the management system.
- Internally disclose knowledge about environmental protection issues and technical-organizational measures in this regard.
- Promote and raise awareness of employees on "responsibility" towards prevention and environmental protection, developing informational and training programs for staff.
